With respect to the clothing checklist, we encourage you to modify the list to accurately reflect what your son is bringing to camp and then tape this on the inside of his trunk. Please be sure that your son brings a sleeping bag and that all of his gear has his name on it. Many of these items can be purchased at your local department store or through Amerasport. Not all are necessary for your son's experience. To see our available camp items, you can visit www.amerasport.com or click on the Amerasport link on our website and type in William Lawrence Camp in the request box. For website purchases, be sure to order early to ensure that you will receive items before the start of camp.

The State of New Hampshire requires that every camper shall furnish a health history and physician's statement of health status written within two years of camp entrance. The physician's statement shall include a certification that a physical examination has been completed within two years prior to camp entrance. The medical form must have been updated within six months prior to camp.

Be sure to review the 'Behavior & Responsibilities of the Camper' with your son(s), which outlines basic behavioral expectations. To ensure a safe, fun and rewarding camp experience for everyone, we request that you share this and other relevant information from the Parents' Guide with your son. Please review and sign the Parent Checklist & Statement of Understanding and send this along with your other completed forms. Please also have your son sign this form. By doing so, he will be acknowledging his commitment to helping camp be a wonderful place for all participants.
